



Florida Association of School Resource Officers Agency of the Year Award

Submission Criteria

The Florida Association of School Resource Officers “Agency of the Year” Award is presented annually to an agency that has made a significant contribution to the development of the School Resource Officer profession. This award recognizes an agency that has made an impact in training, professional development and organizational efficiency in order to make schools in their community a safer place to learn.

Submission Guidelines

1. The award submission packet must include the following:
2. The “Agency of the Year” Award nomination form must be completed in full and submitted prior to the deadline.
3. The nomination packet must be endorsed by the head of the Law Enforcement Agency with the endorsement letter on agency letterhead, signed by the head of the agency.
4. A written submission, not to exceed more than 2500 words, double spaced can be included.
5. No more than 10 photos should be embedded in the written submission.
6. A video submission not more than 10 minutes can be included in the submission (only one video file will be permitted).
7. A summary statement not more than 300 words must be included (to be used on the FASRO website and at the conference to highlight the “Agency of the Year”).
8. Supporting documentation such as letters of commendation or recommendation is recommended.
9. Award nominations not submitted as directed will be forfeited.

Selection Process

Deadline for submission is May 1, 2018. All award submissions will be reviewed and voted upon by the members of the “Agency of the Year” awards committee. The Agency chosen as FASRO “Agency of the Year” will be contacted after the selection process and congratulated for their achievement.

Awarding of Achievement

The agency chosen as the FASRO “Agency of the Year” will be recognized during the opening ceremony at the annual FASRO conference. The winning agency is given a select amount of time during the ceremony to accept the award and showcase their agency video. The winning agency will be contacted by FASRO with the ceremony specifics prior to the conference. Those specifics shall include the following

1. One four minute video highlighting the winning agency.
2. Only five minutes will be allocated for the acceptance of the award; this time includes any VIP endorsement or congratulations to the agency.
